Web Video Production Artist Release Form

The undersigned "We" or "I" hereto enters into this Agreement with **VideoCentricity.Net a.k.a. Fidmania Hosting** ("The Producer").

I have been informed and understand that Producer is producing a videotape program and that my name, likeness, image, voice, appearance and performance is being recorded and made into a live on-demand video presentation of me on the internet as a finished part of that production ("Product").

CONDITIONS

- ◆ The Producer agrees to showcase such video works in an attractive setting, and will not use any part of the whole recording in any fashion as to demean the artist, specifically known as 'Bloopers', nor will the producer sell or profit from release or unauthorized use of the video by any third party company who might gain or benefit from ownership either in contests, television shows, or other film industry footage
- ◆ In return for shooting such video, editing and post-production at no cost to me, and authoring the end-result to a public showcase website, I grant the Producer and its designees the right as may be supplied without limit or specific exception with such ancillary compensation in full and personal promotion if any, as follows.
- ◆ The Producer has the right to use my name, likeness, image, voice, appearance and performance as embodied in the Product whether recorded on or transferred to videotape, film, photographs or other media, now known or later developed. This grant includes without limitation the right to edit, mix or duplicate and to use or re-use the Product in whole or part as Producer may elect. The Producer shall have complete artistic control of the Product in which I appear, including addition of Fidmania copyright notices, and I acknowledge that I have no interest or ownership in the final Product or its copyright.
- ◆ I also grant Producer and its designees the right to exhibit the Product, either in whole or in parts, and either alone or with other products, together with internet advertising space for commercial gain from advertisers. i.e. Paid advertising on the same web pages. This grant includes the right to use the Product for promoting or publicizing any of the uses.
- ◆ I confirm that I have the right to enter into this Agreement, that I am not restricted by any commitments to third parties, and that Producer has no financial commitment or obligations to me as a result of this Agreement. I hereby give all clearances, copyright and otherwise, for the use of my name, likeness, image voice, appearance and performance embodied in the Product. I expressly release and indemnify Producer and its officers, employees, agents and designees from any and all claims known and unknown arising out of, or in any way connected with, the above granted uses and representations. The rights granted Producer herein are perpetual and worldwide.
- ◆ In consideration of all of the above, I hereby acknowledge receipt of reasonable and fair promotion of my talent as consideration from Producer. I have the right to withdraw and terminate this contract at any time and have my video removed from the Producers internet showcase.
